

## 关于签证费报销的相关规定及要求

温馨提示：建议通过 EMS、顺丰等大型快递公司进行邮寄，以确保材料的准时送达，保证派出手续的顺利办理。

### 一、邮寄方式办理报销签证费流程

您在上海集训部公派留学服务系统的“信息沟通”内收到可以邮寄材料的回复后，方可寄出材料。请在寄出材料前，确保您已完成国家留学基金委规定的相关手续，主要包括：“同意派出函”已审核通过；《资助出国留学协议书》已审核通过。如未完成基金委的相关手续，我部无法为您办理汇款。

#### 第一步、准备所需材料

1、签证页的复印件

2、签证费报销凭证（具体要求请以“信息沟通”内收到的留言为准，样张请参看后文）

#### 第二步、审核通过后邮寄至以下地址

#### 第三步、报销汇款

我部在收到您邮寄过来的材料后，会尽快进行审核，审核通过后以汇款的形式将相关费用汇至本人的人民币借记卡账号。如您的材料有任何问题，我部将在上海集训部公派留学服务系统的“信息沟通”内及时告知，请关注您的“信息沟通”。

### 二、签证费报销的原则

1、报销国家公派留学人员本人的签证费用。

2、仅能报销一次。

3、针对获得的有效签证进行报销；拒签或撤签的不予报销，签证类型不符合要求的不予报销。

4、针对顺利出行的签证进行报销；即使获得了有效签证，但未执行国家公派任务的不予报销。

5、如在办理签证时有加急、邮寄等情况者，加急、邮寄等费用不予报销，仅能按照一般签证的费用予以报销。

6、自费转公派性质的留学人员，如在获得国家公派资格前自行办理签证，并赴留学所在国的，之前以自费出国留学身份办理的签证，签证费不予报销。

7、提供了有效的签证费报销凭证；传真件、复印件、扫描件等影印资料不能作为报销凭证。

8、原则上仅能报销本年度内的签证费，如涉及跨年报销的情况，需由于客观原因所致，申请人需额外提供详细情况说明。是否能够报销，需通过我部审核。

### 三、关于签证费报销凭证

（一）根据所赴国别的不同，报销凭据主要分为以下 4 种情况：

1、如在使领馆现场缴纳签证费，请凭使领馆开具的签证费收据原件办理签证费报销。

2、如在签证中心现场缴纳签证费，请凭签证中心开具的机打签证费收据原件办理签证费报销。

3、如在线支付签证费，请凭领馆或移民局发送的电子收据办理报销，注意：任何汇款凭证无法作为报销凭证。

4、如通过代办机构办理，请凭代办机构出具的正式发票（发票抬头：申请人姓名；项目明细：签证费）。

5、如果有使领馆指定官方签证中心，但通过其他中介办理的签证，中介无法提供官方签证中心收据或发票原件的，中介收据或发票无法报销。

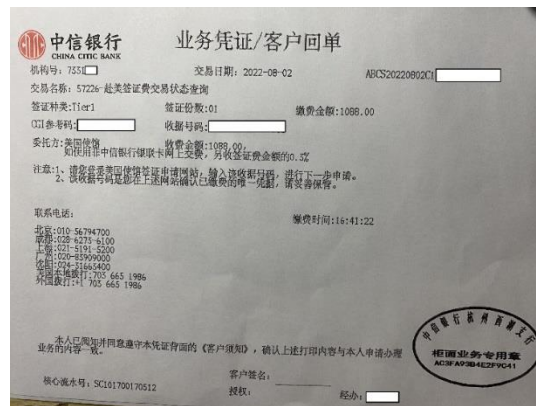

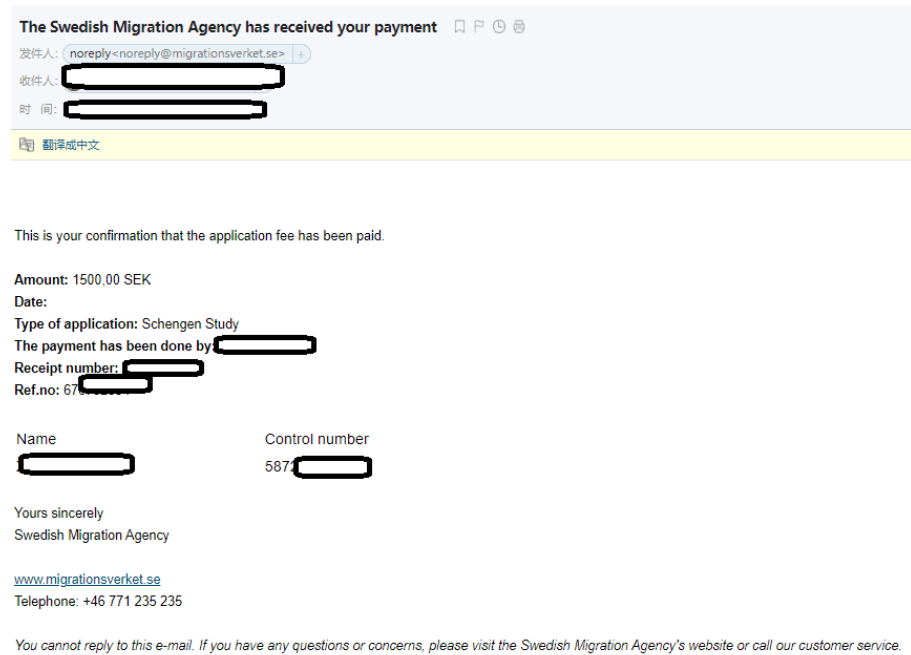


